### **Modalities for conducting the Term End Practical (TEP) Examination virtually for MCA, BCA and CIT practical courses of SOCIS:**

- Scope of the viva-voce questions will be around the current semester practical assignments of that course.
  - The students will not be asked to write code/program, however, their knowledge and skills, subject understanding will be evaluated through viva-voce only.
- The students eligible to appear for the practical examinations are those who qualify the criteria set by SED for appearing in Term End Examinations (TEE) to be held from 26<sup>th</sup> September, 2020 (and have applied for appearing in Term End Practical Examinations).
  - The term end practical examination will be conducted purely in virtual mode only.
  - Passing criteria/Maximum marks etc., for each practical course will remain the same and there won't be any change (refer to your MCA programme guide).
  - The practical courses which consists of more than one section (for example MCSL-017, MCSL-025, MCSL-036, MCSL-045, MCSL-054 etc), the student need to appear in the section(s) in which s/he is not yet successfully completed.
  - Attendance will be taken for students appearing for Term End Practical (TEP) Examination, June, 2020.
  - Practical viva-voce sessions are recorded for future reference.
